## The conspiracy behind pro-Jallikattu uprising in Tamil Nadu (Part-I) (by N.T.Ravindranath)

The recent developments in Tamil Nadu over Jallikattu ban, is a matter of grave concern. Because, it was not a mere pro-Jallikettu movement. It was in fact an anti-Modi, anti-Centre and pro-Eelam uprising. There were more anti-Modi slogans than pro-Jallikettu slogans at the Marina venue of agitation. Many children were seen at the venue with placards, with filthy abuses on Modi, hung around their necks. Slogans raised by the gathering included "Today the bull and tomorrow, a separate Tamil Nadu". At least 15 effigies of Modi were brought by different groups of volunteers to be burnt at the venue. However, the police prevented them from burning the effigies, so they smashed it all on the ground. There were many cutouts of LTTE leader Veluppilli Prabhakaran and Islamic terrorist Osama Bin Laden at the venue. More than 3000 Muslims had taken part in Jallikattu uprising at Marina. They held regular 'namaz' at the venue itself. The media had reported that the uprising against Jallikettu ban was spontaneous movement and there was no leader involved in organizing it. This is not correct. It is true that it was not organized by any political party. After the defeat of LTTE and killing of LTTE leader Veluppilli Prabhakaran in the civil war in Sri Lanka, about a dozen pro-Eelam organizations like "Nam Tamil Ilakayam" (We Tamils Movement) and "Vidutalai Chiruthigal Katchi" (Liberation Movement), mainly consisting of erstwhile supporters of LTTE, had sprung up in Tamil Nadu with the objective of striving for attaining the LTTE goal of a sovereign Greater Tamil Nadu. The CIA had supported the LTTE as its aim of achieving a greater Tamil Nadu comprising of Tamil speaking areas of northern and eastern areas of Sri Lanka and the Indian state of Tamil Nadu was in tune with the CIA's agenda of balkanization of India. It is for the same reason that after the demolition of LTTE in Sri Lankan civil war, the CIA helped pro-LTTE elements in Tamil Nadu to establish a number of pro-Tamil Eelam organizations in Tamil Nadu. These pro-Tamil Eelam organizations, some Islamic fundamentalists and some militant Christian leaders like S.P.Udaya Kumar who had led the anti-Kudankulam nuclear power plant agitation in Tamil Nadu, were the main organizers of this uprising. However, these pro-Tamil Eelam separatist organizations could not make much headway in Tamil Nadu so far because of the ever growing influence of charismatic AIADMK leader and state chief minister Jayalalita. She may have been corrupt and arrogant. But, she was a true nationalist and a good administrator. Jayalalita was not a Tamil fanatic and hence never allowed Tamil separatist elements to whip up Tamil separatist sentiments in the state. Nor did she give any scope for such elements to grow and gain strength in Tamil Nadu. Thus, Jayalalita had become the greatest hurdle against the Tamil separatist movement in Tamil Nadu. Under the circumstances, the

mystery behind Jayalalita's sudden death needs a very thorough investigation. Within just two months after the death of Jayalalita, the Tamil separatists and other antinational elements like Christian and jihadi militants and Maoists were able to organize a joint uprising to whip up anti-Modi and anti-Centre sentiments among Tamils under the banner of pro-Jallikettu revolt is a matter of grave concern. The way the massive weeklong orderly agitation was conducted, without a visible leader in the forefront, without the participation of any political party and with 24-hour coverage on different TV channels clearly indicated the hand of a superior guiding force like the CIA. How the state was paralyzed for a week with people taking to the streets at various centres in the state and others glued to the TV sets to know the latest development was reminiscent of the "India Against Corruption" movement led by Anna Hazare in Delhi in 2011. After the exposure of various mega scams in the country like 2G, Coal Scam, Commonwealth Games scam, etc. the people all over the country were very much agitated in 2011 over the magnitude of the scams in the country. This emotive issue of corruption was selected and exploited by some pro-US elements in Delhi to start an "India Against Corruption" movement in Delhi in 2011. A known anti-corruption crusader Anna Hazare of Maharashtra was roped in to lead the agitation to give some respectability to the movement. The movement drew massive response from the people and Delhi was paralyzed for two weeks. While the Delhi movement was aimed to catapult an hitherto unknown bureaucrat and NGO leader Aravind Kejriwal to the centre stage of politics to lead an anti-Modi movement, the Jallikettu movement in Tamil Nadu was aimed to generate anti-Modi sentiments among the Tamils so as to stem the growing influence of Modi in Tamil Nadu and also to whip up Tamil separatist sentiments among the Tamils with the ultimate objective of inciting them to fight for a separate, independent, Greater Tamil Nadu.

The Supreme Court is scheduled to hear some fresh petitions challenging the validity of the recent Tamil Nadu Government's ordinance lifting the ban on Jallikattu, on January 30, 2017. The final verdict on a pending Supreme Court case on Jallikattu will also be delivered on the same day. If the Supreme Court verdict goes against the state government, there will be very serious consequences in Tamil Nadu, as separatist elements will get a big boost to start a militant secessionist movement in Tamil Nadu. Hence, if the S.C. verdict goes against holding of Jallikattu, then the Union government should come out with an ordinance to overcome the hurdle and show Supreme Court its place. Otherwise Tamil Nadu will burn.

It is not only the Tamil separatists, but the entire Tamil community supports Jallikettu. That is why, the organizers of the Jallikattu uprising were able to muster such a massive

gathering at Marina beach. In fact, the entire South India supports Jallikattu and resents the interference of the court in such matters. Jallikattu is a harmless ancient rural sport in southern parts of Tamil Nadu. Why should the court take the side of some western-funded activists and become a party to create social tension in the country? Under pressure from some animal rights activists, the Cochin High Court last year had tried to put some restrictions on parading elephants during "Trichur Pooram" which is a world famous festival of Kerala. When the organizers of the "Pooram" decided not to conduct the festival, the state government became jittery and issued an ordinance to remove the restrictions imposed on elephant parade. Such unwanted interventions by the courts will only lead to social disharmony. But, that is what the western agencies want. PETA, which wants a ban on Jallikattu, is an American organization. The Tamil separatists who want a ban on PETA, are funded by the western intelligence agencies. This is the irony of the situation. The government should see through this game and ban all such western agencies involved in destabilization activities in India.
